### **HOW TO REGISTER FOR AUCTION & OTHER RULES**

## ALL VEHICLES ARE SOLD "<u>AS IS – WHERE IS</u>" WITH NO GUARANTY OR WARRANTY OF ANY KIND. Acceptable payment is CASH ONLY.

A person must have a bidder's number to be allowed to bid on a vehicle in the auction. A bidder must register prior to the auction start time in the main office at 314 SW 29<sup>th</sup> in person. Auction Registration starts at 9:00 AM the day of the sale. The new bidder will need a government issued photo ID to present when registering for a bidder number. You will have to fill out and sign a responsibility form. This will put the bidder's name on the bidder list. The bidder may sign up for text to get a list of the vehicles scheduled for the next auction on Monday before the sale or get a copy in the office. Vehicles may be pulled, paid out or cancelled at the last moment. The list is not a guarantee of a sale. Registration closes at 10 AM.

If a licensed dealer wishes a bid number and to use the dealership's name we must see a Used Motor Vehicle Commission ID card to use the dealership name plus the photo ID.

First time bidders will be assigned a temporary number to use for the first auction only. A week before the next auction a postcard will be mailed to the new bidder with a permanent bidder number. Or the new bidder may "check in" at the main office the morning of the next auction and obtain the permanent bidder number that has been assigned.

An assigned bidder number will be valid for 10 weeks after registering. If a bidder has not checked in at the office <u>or</u> purchased a vehicle in 10 weeks, that bidder's name will be removed from the mailing list. That's approximately 5 auctions.

Auctions are held every other Tuesday at 10 AM. However, auction days and times may change without notice due to weather conditions or other extenuating circumstances.

All bids are for CASH ONLY (except for licensed dealers). We do not accept personal checks, business checks (except licensed dealers), credit cards or drafts. Vehicles must be paid for on the day of the sale. Any vehicle not paid on the day of the sale can be resold without notice. If we do not resell the vehicle payment must be received by Friday morning after the auction or a 10% fee will be added to the bid amount. Failure to pay for a vehicle (renege) within 5 days will result in being barred from future auctions unless a deposit is paid prior to the next sale. Two reneges and the bidder will be barred from the auction lot indefinitely.

A handout instruction sheet explaining the paperwork to title a vehicle is available at Puckett's upon request. It can take 10 to 14 weeks to get a valid title once turned in to the Oklahoma Tax Commission. Any other questions should be asked <u>PRIOR</u> to bidding on any vehicle.

If you purchased the vehicle for parts, you will not be required to title the vehicle. If you wish to obtain a title for the vehicle you purchased at the auction you will need to turn in the Title 42 to Service Oklahoma MVD. It could take up to 6 weeks to get the Title 42 approved (normal time 37 days). You will not be required to pay for back tags and taxes on any title 42. Titled vehicles could have back taxes due. You will have 30 days to title the vehicle on a title 42 when approved by OTC/MVD to obtain the title without penalty. Late penalty fees increased to \$3.00 per day for tag, title, Sales Tax and Excise tax (11/01/18).

## NOTICE - SALVAGE/REBUILT TITLES & JUNK Vehicles

Any vehicle less than 10 years old may have a Salvage Title issued if the insurance company has mailed in a letter to the Tax Commission.
