HOW TO REGISTER FOR AUCTION & OTHER RULES

ALL VEHICLES ARE SOLD "AS IS – WHERE IS" WITH NO GUARANTY OR WARRANTY OF ANY KIND. Acceptable payment is CASH ONLY.

A person must have a bidder's number to be allowed to bid on a vehicle in the auction. A bidder must register prior to the auction start time in the main office at 314 SW 29th in person. Auction Registration starts at 9:00 AM the day of the sale. The new bidder will need a government issued photo ID to present when registering for a bidder number. You will have to fill out and sign a responsibility form. This will put the bidder's name on the bidder list to receive. The bidder may sign up for text to get a list of the vehicles scheduled for the next auction on Monday before the sale or get a copy in the office. Vehicles may be pulled, paid out or cancelled at the last moment. The list is not a guarantee of a sale. Registration closes at 10 AM.

If a licensed dealer wishes a bid number and to use the dealership's name we must see a Used Motor Vehicle Commission ID card to use the dealership name plus the photo ID.

First time bidders will be assigned a temporary number to use for the first auction only. **NEW BIDDERS ARE LIMITED TO THREE (3) VEHICLES FOR FIRST AUCTION ATTENDED.** The new bidder needs to "check in" at the main office the morning of the next auction and obtain the permanent bidder number that has been assigned. That will be a permanent number until non-use (6 months) or until bids aren't honored.

An assigned bidder number will be valid for 6 months after registering. If a bidder has not checked in at the office or purchased a vehicle in 6 months, that bidder's name will be removed from the Bidder List. That's approximately 12 auctions.

Auctions are held every other Tuesday at 10 AM. However, auction days and times may change without notice due to weather conditions or other extenuating circumstances.

All bids are for **CASH ONLY** (except for licensed dealers). We do not accept personal checks, business checks (except licensed dealers), credit cards or drafts. Vehicles must be paid for on the day of the sale. Any vehicle not paid on the day of the sale can be resold without notice. If we do not resell the vehicle payment must be received by Friday morning after the auction or a 10% fee will be added to the bid amount. Failure to pay for a vehicle (renege) within 5 days will result in being barred from future auctions unless a deposit is paid prior to the next sale. Two renege and the bidder will be barred from the auction lot indefinitely.

A handout instruction sheet explaining the paperwork to title a vehicle is available at Puckett's upon request. **It can take 6 to 14 weeks to get a valid title once turned in to Service Oklahoma Motor Vehicle, Title42.** Any other questions should be asked **PRIOR** to bidding on any vehicle.

Title 42s will be ready within 10 days after the auction. Make sure we have the correct name and phone number when paying for a vehicle.

You must pay for the auction vehicle by 5:00 PM on auction day. Unpaid vehicles can be resold without notice or recourse if not paid on the day of the auction. You will be barred from future auctions if you don't pay for the vehicles you bid on.

Any vehicles not paid by Friday AM after the auction will have a 10% service fee added.

You are responsible for any vehicle purchased using your bid number. Please show your number to avoid errors. Do not share your bid number.

You must pick up the title 42 in our office OR request we send it to the Service Oklahoma Motor Vehicle for you when completed.

If a vehicle has key it will be highlighted on the Auction Key List prepared the day before the auction. Vehicles marked "Lot 2" or "drives" means the vehicle has moved under it's own power and was in our drivable lot (unless it is out of gas or needs a jump start). We cannot test drive vehicles on streets so we don't know the drivability of the vehicle, just that it moves under its own power.

Paid vehicles left over 4 days may be sold without recourse. Please notify us if you need additional time to pick up a vehicle.

If you purchased the vehicle for parts, you will not be required to title the vehicle. If you wish to obtain a title for the vehicle you purchased at the auction you will need to turn in the Title 42 to Service Oklahoma MVD. It could take up to 6 weeks to get the Title 42 approved (normal time 37 days). You will not be required to pay for back tags and taxes on any title 42. Titled vehicles could have back taxes due. You will have 30 days to title the vehicle on a title 42 when approved by OTC/MVD to obtain the title without penalty. Late penalty fees increased to \$3.00 per day for tag, title, Sales Tax and Excise tax (11/01/18).

NOTICE – SALVAGE/REBUILT TITLES & JUNK Vehicles

Any vehicle less than 10 years old may have a Salvage Title issued if the insurance company has mailed in a letter to the Tax Commission. We may not have knowledge of this event and we cannot be held responsible. Many times the Salvage Letters are mailed months after the settlement. Do not forget this. If we know there is a Salvage Title it will show on the list. **That doesn't mean there isn't a Salvage Title in the vehicle's future. These vehicles are sold "As Is-Where Is" with no guarantees or warranties expressed or implied. JUNK Vehicles are PARTS ONLY and cannot be driven or titled.**
